GENERAL: Registration is FIRST COME FIRST SERVE.

Camp starts June 23 (Monday) and runs through August 29 (Friday). Camp Hours are 9am to 12pm (PeeWee) OR 9am to 3pm (Pee Wee and Junior) – Extended Day from 3pm-6pm (Pee Wee and Junior). Camp is for children 2 to 8 years old– (Pee Wee & Junior Camp) Children bring their own lunch- (we will provide snacks and refreshments). Days are final and cannot be rescheduled. NO MAKE UP FOR MISSING DAYS. Groups will open with a minimum of 5 children.

TUITION:

- To reserve you a spot in our camp a deposit of 50% of the total tuition must be received at Registration (OR by MAY 1).
- DUE BALANCE must be received by JUNE 1. FULL TUITION is due before June 1.
- All registrations, **RECEIVED AFTER JUNE 1, and those registrations, which have a pending balance AFTER JUNE 1st, will be wait-listed and placed in days/weeks where space is available.**
- **UPDATED HEALTH FORM MUST BE RECEIVED BY JUNE 1ST. AFTER JUNE 1ST A \$25 FEE WILL APPLY.**

SOME WEEKLY DAY TRIPS may require additional expenses (i.e. entrance) that are not included and **MUST** be paid separately **BEFORE THE DAY OF THE TRIP**.

REFUNDS:

Tuition refundable ONLY if cancelled BEFORE May 1 (\$50 non-refundable cancellation fee applies).

After May 1th absolutely no-refunds for any reason.

Schedule changes possible until June 1st. After June 1st, only upon availability.

NO DISCOUNTS FOR ABSENCES OF ANY KIND. NO MAKE UPS AVAILABLE . NO CREDIT FOR FUTURE. In case of serious medical condition that makes it impossible for a child to participate at all in our camp, a **medical certificate** (signed by a doctor who is not a parent of the child) must be presented stating such condition and it will be, at discretion of Juguemos, to give credit for future classes during the **current** school year if appropriate.

Service Fee: \$20 for any returned check from the bank.

DISCOUNTS:

- \$100 off (one hundred dollars) total camp fees if enrolled in 6 OR MORE FULL WEEKS and PAY IN FULL by FEBRUARY 24th (CASH OR CHECK ONLY – no credit card)
- \$200 off (two hundred dollars) total camp fees if enrolled in 10 FULL WEEKS and PAY IN FULL by FEBRUARY 24TH (CASH OR CHECK ONLY – no credit card)
- \$10 off (ten dollars) if enrolled and PAY IN FULL by April 30th. (CASH OR CHECK ONLY- no credit card)
- Returning 2013 Campers and Preschool students 2013-2014 & 2014-2015: \$20 off (twenty dollars) if ENROLLED IN 4 (FOUR) OR MORE WEEKS.
- Discounts are separate and cannot be combined.

I agree to pay Juguemos a Cantar the full tuition by June 1st 30 of the current year. If enrolled after June 1st, I understand that full tuition is due at time of registration. I understand that Tuition and Deposits are non-refundable. Juguemos a Cantar has the unrestricted right to terminate this enrollment agreement at its discretion. I am the parent/guardian, give my consent for my child, to go on local walks/days trips during the Summer camp with the teachers and designated staff. I certify that my child has no known medical or other conditions that could interfere with his/her participation in Juguemos a Cantar activities. I hereby release, discharge and hold harmless Juguemos a Cantar, and any of its instructors or staff, from any claims and all claims whatsoever, including but not limited to any claim of negligence or gross negligence that could otherwise be asserted arising out of or relating to any injuries physical or emotional that may result to my child while participating in any Juguemos a Cantar activity, or as a result of such activities. I understand that in case of emergency, I will be contacted or they will contact the emergency number that I provided. I understand that my child will be taken to the ER of nearest Hospital in case of emergency and I will be responsible for any and all payments subsequent as well as any and all follow ups that medical staff deems necessary. **PHOTOS:** I understand that for its promotional activities, Juguemos a Cantar may utilize photographs of the participating children and its parents or caregivers (without their names) while engaged in our classes. By signing below I consent to such use and waive all rights to compensation. I grant permission for my child to watch G-rated movies and educational children's videos. If Juguemos finds it necessary to withdraw my child from the Program, I will be responsible for payment for the number of days and/or weeks s/he attended prior to the withdrawal date. **BEHAVIOR.** Juguemos seeks to uphold the Community Standards established as the code of conduct at Juguemos.
