Campers Behavior Expectations and Procedures

1. **Attendance Requirements:** Children are expected to attend camp each day they are registered. They will not be accepted if they are not in the attendance. If a child is absent for 3 or more days, a medical certificate is required to be accepted in camp again. As per the Department of Health regulations, any contagious illness or epidemic (such lice) should be informed immediately to the program and their camp teacher, and the camper cannot return until his/her condition has been cleared by a doctor. _____(initials)
2. **Dismissal Procedures:** All campers will only be released to an authorized person each day. Campers will not be released to persons that are not on our authorized pick up list. Teachers and the program director must be notified of any changes in writing (text/e-mail) by a parent or guardian. _____(initials)
3. **Behavior Expectations:** Campers are expected to follow Juguemos Cantar behavior expectations; we hold the right to remove a camper if he/she fails to comply with appropriate behavior. Campers will use their words (no hitting or pushing). Campers will listen to the teachers. Campers will respect their peers and their belongings. Counselors will be role models. _____(initials)
4. **Disclaimer:** Parents are *obligated* to notify the staff if there are any problems or concerns with the children. Parents will notify staff of any changes in medical problems or personal concerns. Our door is always open, and parents are encouraged to keep good communication with our staff. Everything will remain confidential and with the child's best interest. (This includes: Allergies, behavior/ speech/ physical therapies, and medication with behavior side effects). _____(initials)
